The Technical Advisory Committee, in view of the special circumstances surrounding the **IBEX GROWTH MARKET® ALL SHARE** index, due to the capital increases by IFFE Futura, S.A.,

- With effects from the date of admission of the new shares, **to modify the free float factor of the stock IFFE FUTURA (IFF) for index calculation purposes of the IBEX GROWTH MARKET® ALL SHARE index**, transitioning from an 80% to a **30%**.
- With effects from the date of admission of the new shares, **to adopt the change in the corporate denomination and ticker symbol of the stock IFFE FUTURA (IFF)**, in accordance to the corresponding Operational Instruction ( [https://www.bmegrowth.es/docs/documentos/Avisos/2023/11/71613\\_Aviso\\_20231121\\_2.pdf?9EoHLQ](https://www.bmegrowth.es/docs/documentos/Avisos/2023/11/71613_Aviso_20231121_2.pdf?9EoHLQ) ).
- The adjustment to modify the free float factor of the value mentioned, along with the integration of the newly issued shares, will take place at the close of the session preceding the effective date of admission of the new shares, scheduled for November 23<sup>rd</sup>.
