



Business Description

Duro Felguera SA is a Spain based company engaged in executing turnkey projects for the energy, industrial and oil and gas sectors. It supplies specialized services for industries and manufactures capital goods. The company is involved in carrying out integrated projects for the construction of power generation plants, mineral treatment and bulk-handling facilities, fuel storage plants and other facilities and installations for the oil and gas industry. In the services area, the organization specializes in the erection of energy and industrial facilities. The business segments of the group are Energy; Mining and Handling; Oil and Gas; Services; Manufacturing of capital goods; and Communications

Valuation ^Qas of 18 May 2024

Morningstar affirms a 3-star quantitative rating for Duro Felguera. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 0.60, a discount of 14.03% to its Quantitative Fair Value estimate of 0.70. This discount has ranged between 40.19% and 0.5% over the past year. The stock's price to fair value ratio is at the 66th percentile in our global equity coverage universe for this methodology and at the 50th percentile relative to its peers in the industrials sector.

Duro Felguera furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from High to Very High after 05/16/2024.

We examine the financials and market statistics for Duro Felguera to determine these ratings. Its earnings yield is 7.12% and its trailing 12-month maximum drawdown is 28.18%. These fall at the 77th and 48th percentiles in the equity universe and at the 74th and 56th in the industrials sector, respectively.

Economic Moat ^Q as of 20 May 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Duro Felguera falls at the 41st percentile in the industrials sector and at the 46th in the equity coverage universe. The company has maintained its None quantitative moat rating since after 07/03/2023, when it was downgraded from Narrow.

We also assign a Moderate quantitative financial health rating to Duro Felguera. The company's raw score on this metric, termed Distance to Default, ranks at the 32nd percentile overall and 31st in the industrials sector. Furthermore, this financial health rating most recently changed from Strong after 09/29/2023.

Supporting these ratings are the company's enterprise value and annualized trailing 12-month volatility. The enterprise value of 269.37 million, ranks at the 50th percentile in the covered equity universe and at the 43rd percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 25.58%, falls at the 35th percentile in the universe and the 40th percentile in the industrials sector.


Duro Felguera maintains earnings per share of 0.06. We do not have enough information to report on the company's return-on-invested-capital and dividend yield.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
