




Business Description

Promotora de Informaciones SA operates under the commercial name 'Prisa' which is a multimedia group in Spain and Portugal. The business is operated through various segment which includes Education, Radio, Press, and others. Its Education segment includes primarily the sale of educational books and the services and materials related to the education systems. Geographically, it operates in Spain, Portugal, Chile, Brazil, Mexico, and other countries out of which Spain accounts for most of the revenue for the company.

Valuation ^Qas of 18 May 2024

Morningstar maintains a 3-star quantitative star rating for Promotora, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.36, below our quantitative fair value estimate of 0.50. These shares have traded between a 46.71% and 8.69% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 40th percentile; in the communication services sector, the firm's score lies at the 47th percentile (higher percentile indicates more undervalued).

Furthermore, Promotora maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating over the past year. The uncertainty rating for Promotora has remained Very High since the previous rating of Extreme, which was last assigned on 01/09/2024.

The key factors behind these ratings are the company's EV-MV ratio and drawdown. The enterprise value-to-market value ratio is 2.91, and its maximum trailing 12-month maximum drawdown is 40.84%. The EV-MV ratio falls at the 92nd percentile in the communication services sector while the

drawdown is at the 54th percentile. Over the past year, the company's EV-MV ratio has been between 2.89 and 3.86; its drawdown has ranged between 18.88% and 40.84%.

Economic Moat ^Q as of 20 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.53 sits at the 54th percentile in the communication services sector. This is a decrease from 0.68, the maximum of its moat scores over the past year.

The quantitative financial health rating for Promotora is Moderate. Its financial health score, termed Distance to Default, sits at the 27th percentile in the universe and 30th percentile in the sector.

The significant drivers of these ratings are the company's enterprise value and annualized trailing 12-month volatility. The enterprise value for Promotora is 1.18 billion, and its annualized trailing 12-month volatility is 26.08%. They sit at the 66th and 36th percentile in the global equity universe, respectively.

Fundamentals as of 18 May 2024

The earnings per share for Promotora is -0.02. We do not have enough information to report on the company's return-on-invested-capital and dividend yield. The company did not report a dividend.

Examining valuation further, the company's priceto-free cash flow ratio is 8.77, greater than 30% of its sector peers. These values are calculated using the stock's price at last market close.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future.
