



### **Business Description**

Urbas Grupo Financiero SA is a Spain-based company mainly engaged in the real estate sector. Its activities include the acquisition, development, and sale of land and properties, mainly in the regions of Guadalajara and Almeria.

### Valuation as of 18 May 2024

Morningstar maintains a 3-star quantitative star rating for Urbas Grupo Financiero, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.0041, below our quantitative fair value estimate of 0.0053. These shares have traded between a 67.3% and 23.26% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 46th percentile; in the industrials sector, the firm's score lies at the 28th percentile (higher percentile indicates more undervalued)

Furthermore, Urbas Grupo Financiero maintains a quantitative valuation uncertainty rating of Very High

The company has held this star rating over the past year. The uncertainty rating for Urbas Grupo Financiero has remained Very High since the previous rating of Extreme, which was last assigned on 04/01/2024.

The key factors behind these ratings are the company's earnings yield and drawdown. The earnings yield is 9.27%, and its maximum trailing 12-month maximum drawdown is 76.76%. The earnings yield falls at the 83rd percentile in the industrials sector while the drawdown is at the 72nd percentile. Over the past year, the company's earnings yield has been between 5.26% and 11.21%; its drawdown has ranged between 38.10% and 76.76%.

### Economic Moat <sup>Q</sup>as of 20 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.02 sits at the 5th percentile in the industrials sector. This is a decrease from 0.2, the maximum of its moat scores over the past year.

The quantitative financial health rating for Urbas Grupo Financiero is Moderate. Its financial health score, termed Distance to Default, sits at the 6th percentile in the universe and 5th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Urbas Grupo Financiero is 339.19%, and its enterprise value-to-market value ratio is 2.17. They sit at the 95th and 89th percentile in the global equity universe, respectively.

### Fundamentals as of 18 May 2024

The earnings per share for Urbas Grupo Financiero are break-even. The company earns a return on invested capital of 2.39%, falling at the 27th percentile in the industrials sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Urbas Grupo Financiero holds a price-to-earnings ratio of 10.79, a figure greater than 24% of its sector peers. The company's price-to-free cash flow ratio is 9.95, greater than 31% of its sector peers. These values are calculated using the stock's price at last market close.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
