



#### **Business Description**

Euroconsult Engineering Consulting Group SA is a civil engineering and construction engineering consulting providers in the Spanish market. The company serves public and private clients to plan, design, build, operate and maintain projects. Its activities are divided into three markets including Transport infrastructures, Architecture and urban engineering and Energy, water and environment. The company provides engineering services to clients in numerous countries, including France, Germany, Poland, Mexico, Brazil or the Dominican Republic. Services offered by Euroconsult include geotechnical engineering, pavement management, structural monitoring, among others. Its main clients are governments, multinational construction companies, concessionaire companies and multilateral organizations.

### Valuation <sup>Q</sup>as of 26 Apr 2024

Morningstar maintains a 3-star quantitative star rating for Euroconsult Eng Consult, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 1.60, below our quantitative fair value estimate of 1.71. These shares have traded between a 20.38% discount and 4.33% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 83rd percentile; in the industrials sector, the firm's score lies at the 73rd percentile (meaning the shares are more undervalued than 73% of stocks in the sector).

Furthermore, Euroconsult Eng Consult maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Euroconsult Eng Consult has remained Extreme since the previous rating of Very High, which was last assigned on 09/07/2023

The key factors behind these ratings are the company's earnings yield and drawdown. The earnings yield is 6.62%, and its maximum trailing 12-month maximum drawdown is 0.00%. The earnings yield falls at the 70th percentile in the industrials sector while the drawdown is at the 5th percentile. Over the past year, the company's earnings yield has been between -1.91% and 6.99%; its drawdown has ranged between 0.00% and 0.00%.

### Economic Moat <sup>Q</sup> as of 26 Apr 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Euroconsult Eng Consult falls at the 87th percentile in the industrials sector and at the 91st in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Strong quantitative financial health rating to Euroconsult Eng Consult. The company's raw score on this metric, termed Distance to Default, ranks at the 77th percentile overall and 78th in the industrials sector. Furthermore, this financial health rating most recently changed from Moderate after 04/02/2024.

Supporting these ratings are the company's earnings yield and enterprise value-to-market value ratio. The earnings yield of 6.62%, ranks at the 74th percentile in the covered equity universe and at the 70th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.34, falls at the 72nd percentile in the universe and the 71st percentile in the industrials sector.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future.
