



Business Description

Inclam SA operates in the engineering and construction industry and specializes in water and climate change sectors. Its business activities are divided into four different main lines: Consulting, Engineering, Procurement and Construction, i.e. EPC, turnkey projects, Project and Construction Management and Climate Change. The company is engaged in specialized water engineering projects. Its business activities include purification, sanitation, desalination, hydraulic works, mitigation, adaptation and emissions trading.

Valuation ^Qas of 3 May 2024

Morningstar maintains a 3-star quantitative star rating for Inclam, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 1.45, above our quantitative fair value estimate of 1.35. These shares have traded between a 17.51% discount and 13.89% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 95th percentile; in the industrials sector, the firm's score lies at the 94th percentile (meaning the shares are more undervalued than 94% of stocks in the sector).

Furthermore, Inclam maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating over the past year. The uncertainty rating for Inclam has remained Very High since the previous rating of Extreme, which was last assigned on 02/23/2024.

The key factors behind these ratings are the company's earnings yield and return on assets. The earnings yield is -8.16%, and its maximum return on assets is 1.95. The earnings yield falls at the 14th percentile in the industrials sector while the return on assets is at the 37th percentile. Over the

past year, the company's earnings yield has been between -8.16% and -8.16%; its return on assets has ranged between -0.47 and 1.95.

Economic Moat as of 3 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Inclam falls at the 89th percentile in the industrials sector and at the 93rd in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Strong quantitative financial health rating to Inclam. The company's raw score on this metric, termed Distance to Default, ranks at the 75th percentile overall and 76th in the industrials sector. Furthermore, this financial health rating most recently changed from Moderate after 04/02/2024

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 16.00%, ranks at the 17th percentile in the covered equity universe and at the 15th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.41, falls at the 75th percentile in the universe and the 74th percentile in the industrials sector.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$ — the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
