



#### **Business Description**

Inclam SA operates in the engineering and construction industry and specializes in water and climate change sectors. Its business activities are divided into four different main lines: Consulting, Engineering, Procurement and Construction, i.e. EPC, turnkey projects, Project and Construction Management and Climate Change. The company is engaged in specialized water engineering projects. Its business activities include purification, sanitation, desalination, hydraulic works, mitigation, adaptation and emissions trading.

### Valuation <sup>Q</sup>as of 1 May 2024

Inclam achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 1.36, below the previous closing price of 1.45. The stock has been trading between a 17.51% discount and 13.89% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 95th percentile in the coverage universe and 92nd percentile in the industrials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Inclam is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 02/23/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its earnings yield and return on assets. The earnings yield of -8.16% falls at the 25th percentile in the equity universe and the 14th percentile in its sector. The return on assets of 1.95 corresponds to the 52nd percentile overall and the 36th percentile in the industry.

### Economic Moat as of 1 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.98 sits at the 91st percentile in the industrials sector. This is a decrease from 0.99, the maximum of its moat scores over the past year.

The quantitative financial health rating for Inclam is Strong. Its financial health score, termed Distance to Default, sits at the 77th percentile in the universe and 79th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Inclam is 16.00%, and its enterprise value-to-market value ratio is 1.31. They sit at the 17th and 70th percentile in the global equity universe, respectively.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
