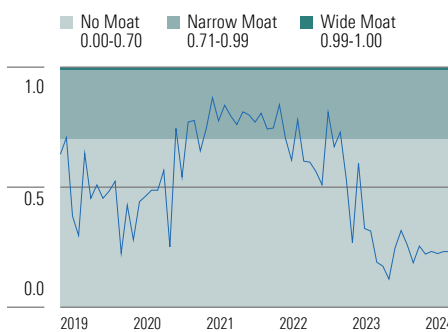

Business Description

Atrys Health SA is a Spain based biomedical company which focuses on developing tools for the diagnosis and treatment of cancer and precancerous conditions. It offers diagnostic services in the fields of pathology, hematology, molecular pathology, and genetics. The company uses telemedicine to provide its services in the medical specialties of radiology, cardiology, ophthalmology, and dermatology.

Valuation ^Q as of 25 Apr 2024

Morningstar affirms a 3-star quantitative rating for Atrys Health. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 2.88, a discount of 37.7% to its Quantitative Fair Value estimate of 4.62. This discount has ranged between 49.05% and 19.34% over the past year. The stock's price to fair value ratio is at the 33rd percentile in our global equity coverage universe for this methodology and at the 52nd percentile relative to its peers in the healthcare sector.

Atrys Health furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating dates to after 09/15/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Extreme to Very High after 04/01/2024.

We examine the financials and market statistics for Atrys Health to determine these ratings. Its enterprise value-to-market value ratio is 2.00 and its sales yield is 90.58%. These fall at the 87th and 64th percentiles in the equity universe and at the 90th and 79th in the healthcare sector, respectively.

Economic Moat ^Q as of 25 Apr 2024

Quantitatively, we do not believe Atrys Health has an economic moat. Its moat score of 0.3 corresponds to the 31st percentile in the healthcare sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.42 in this period (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 43rd percentile overall and the 42nd percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and enterprise value-to-market value ratio. The book value yield is 132.55%, sitting at the 88th percentile in the healthcare sector. The company's enterprise value-to-market value ratio is 2.00, corresponding to the 87th percentile in the equity coverage universe and the 90th percentile in the sector.

Fundamentals as of 25 Apr 2024

The earnings per share for Atrys Health is -0.6. The company earns a return on invested capital of -2.79%, falling at the 53rd percentile in the healthcare sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

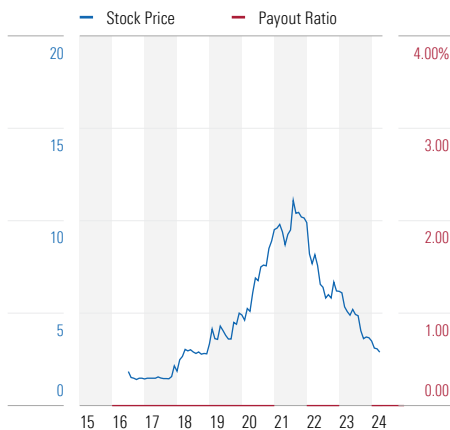

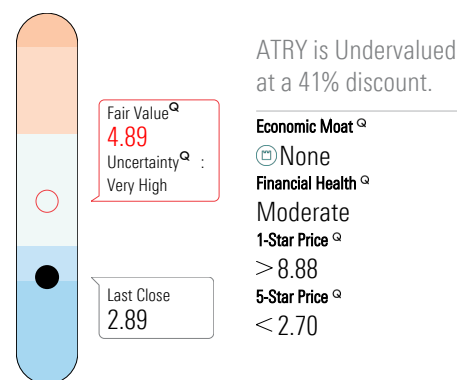

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

None – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%

Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Moderate – assigned when Quantitative Financial Health is between 0.2 and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

Other Definitions

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

Undervalued – Last Price is below Morningstar's quantitative fair value estimate.

Fairly Valued – Last Price is in line with Morningstar's quantitative fair value estimate.
