



Business Description

Izertis SA is a technology consulting company. The company is specialized in providing strategic digital transformation consulting services in areas like AI, Data & Intelligence, Cyber Security, Blockchain, Business solutions, and Smart Software labs.

Valuation as of 30 Apr 2024

Morningstar affirms a 3-star quantitative rating for Izertis. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 8.80, in-line with its Quantitative Fair Value estimate of 8.84. The stock has been trading between a 12.66% discount and 11.75% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 90th percentile in our global equity coverage universe for this methodology and at the 86th percentile relative to its peers in the technology sector.

Izertis furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. Similarly, the firm's uncertainty rating has not changed during this period. We examine the financials and market statistics for Izertis to determine these ratings. Its earnings yield is 2.27% and its annualized trailing 12-month volatility is 12.20%. These fall at the 48th and 6th percentiles in the equity universe and at the 59th and 5th in the technology sector, respectively.

Economic Moat as of 30 Apr 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Izertis falls at the 79th percentile in the technology sector and at the 78th in the equity coverage universe. The company has maintained its Narrow quantitative moat

rating since after 01/01/2024, when it was upgraded from None.

We also assign a Strong quantitative financial health rating to Izertis. The company's raw score on this metric, termed Distance to Default, ranks at the 75th percentile overall and 76th in the technology sector. Furthermore, this financial health rating most recently changed from Moderate after 10/18/2023

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 32.13%, ranks at the 30th percentile in the covered equity universe and at the 44th percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 12.20%, falls at the 6th percentile in the universe and the 5th percentile in the technology sector.

Fundamentals as of 30 Apr 2024

Izertis maintains earnings per share of 0.2. The company further earns a return on invested capital of 6.28%. These values are calculated over a trailing 12-month period.

As of last market close, Izertis has a price-to-earnings ratio of 44, falling below the 72nd percentile in its sector (where a lower percentile means a lower ratio) and ranging between 42.3 and 57.38 over the past year. The company's price-to-free cash flow ratio is 21.97, falling at the 50th percentile in its sector and ranging between 17.02 and 26.84 over the past year.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

Other Definitions

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.

Sustainalytics analyzes over 1,300 data points to assess a company's exposure to and management of ESG risks.
