



### **Business Description**

Euroespes SA is a biomedical research center offering medical, research, medical informatics and bioinformatics services. It offers medicine and personalized treatment for central nervous system disorders and researches genomic medicine. Other services offered by the company include genomics, digital diagnosis, diagnostic imaging, neuro-psychology, neuro-ophthalmology, nursing, epigenetics, clinical analysis and otorhinolaryngology.

### Valuation <sup>Q</sup>as of 1 May 2024

Morningstar maintains a 3-star quantitative star rating for Euroespes, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.54, below our quantitative fair value estimate of 0.64. These shares have traded between a 48.21% and 3.42% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 68th percentile; in the healthcare sector, the firm's score lies at the 78th percentile (meaning the shares are more undervalued than 78% of stocks in the sector).

Furthermore, Euroespes maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Euroespes has remained Extreme since the previous rating of Very High, which was last assigned on 04/26/2024.

The key factors behind these ratings are the company's EV-MV ratio and drawdown. The enterprise value-to-market value ratio is 1.90, and its maximum trailing 12-month maximum drawdown is 3.64%. The EV-MV ratio falls at the 90th percentile in the healthcare sector while the drawdown is at the 5th percentile. Over the past year, the company's EV-MV ratio has been between 1.15 and

1.98; its drawdown has ranged between 0.00% and 3.64%.

### Economic Moat as of 22 Jan 2024

Quantitatively, we believe Euroespes has a Narrow economic moat. Its moat score of 0.9 corresponds to the 88th percentile in the healthcare sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.96 in this period (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 66th percentile overall and the 68th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio is 1.90, sitting at the 90th percentile in the healthcare sector. The company's enterprise value-to-market value ratio is 1.90, corresponding to the 85th percentile in the equity coverage universe and the 90th percentile in the sector.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
