



Business Description

Grino Ecologic is a group of industrial companies which focuses on environmental services and green energy generation. The company operates in environmental services, waste treatment, energy, and construction.

Valuation ^Q as of 26 Apr 2024

Grino Ecologic achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 1.67, above the previous closing price of 1.58. The stock has been trading between a 31.4% and 1.28% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 85th percentile in the coverage universe and 77th percentile in the industrials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Grino Ecologic is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 02/14/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its return on assets and earnings yield. The return on assets of 6.13 falls at the 77th percentile in the equity universe and the 72nd percentile in its sector. The earnings yield of 4.58% corresponds to the 62nd percentile overall and the 56th percentile in the industry.

Economic Moat ^Q as of 26 Apr 2024

Quantitatively, we believe Grino Ecologic has a Narrow economic moat. Its moat score of 0.96 corresponds to the 88th percentile in the industrials sector. Furthermore, this rating has not changed over the past year, while the company's moat score

is near its maximum in this period.

The company also maintains a quantitative financial health rating of Strong. Its score sits at the 95th percentile in both the universe and sector. Examining the company's financials and market statistics, we find these ratings are principally driven by its return on assets and annualized trailing 12-month volatility. The return on assets is 6.13, sitting at the 72nd percentile in the industrials sector. The company's annualized trailing 12-month volatility is 0.00%, corresponding to below the 5th percentile in both the equity coverage universe and

Fundamentals as of 26 Apr 2024

The earnings per share for Grino Ecologic is 0.14. The company earns a return on invested capital of 9.26%, falling at the 67th percentile in the industrials sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
