


Business Description

Zinkia Entertainment SA is engaged in the entertainment sector. It develops and produces television series, movies, and video games. The company's brand profile includes Pocoyo, Mola Noguru, Shuriken School, and others. Its series and apps are distributed on different platforms and devices such as TV, VOD, DVD, mobile devices, YouTube, among others.

Valuation ^Qas of 3 May 2024

Zinkia Entertainment achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 0.60, above the previous closing price of 0.57. The stock has been trading between a 22.9% discount and 1.94% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 85th percentile in the coverage universe and 88th percentile in the communication services sector (higher percentile indicates more undervalued). The quantitative uncertainty rating for Zinkia Enter-

tainment is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 03/13/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and earnings yield. The enterprise value-to-market value ratio of 1.51 falls at the 78th percentile in the equity universe and the 74th percentile in its sector. The earnings yield of 0.87% corresponds to the 40th percentile overall and the 47th percentile in the industry.

tainment falls at the 87th percentile in the communication services sector and at the 90th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Zinkia Entertainment. The company's raw score on this metric, termed Distance to Default, ranks at the 73rd percentile overall and in the communication services sector. Furthermore, this financial health rating most recently changed from Strong after 04/02/2024.

Supporting these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise valueto-market value ratio of 1.51, ranks at the 78th percentile in the covered equity universe and at the 74th percentile among its peers. 

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Weak – assigned when Quantitative Financial Health < 0.2

Strong - assigned when Quantitative Financial Health > 0.7

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.
