



## Valuation as of 26 Apr 2024

Biotechnology Assets achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 0.51, above the previous closing price of 0.36. The stock has been trading between a 54.65% and 20.03% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 43rd percentile in the coverage universe and 62nd percentile in the healthcare sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Biotechnology Assets is Extreme.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 04/24/2024, when it was Very High.

The main drivers of the company's valuation and uncertainty are its earnings yield and sales yield. The earnings yield of 7.68% falls at the 78th percentile in the equity universe and the 94th percentile in its sector. The sales yield of 17.57% corresponds to the 23rd percentile overall and the 42nd percentile in the industry.

## Economic Moat <sup>Q</sup>as of 26 Apr 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Biotechnology Assets falls at the 34th percentile in the healthcare sector and at the 37th in the equity coverage universe. The company has maintained its None quantitative moat rating for the last year. We also assign a Moderate quantitative financial

health rating to Biotechnology Assets. The company's raw score on this metric, termed Distance to Default, ranks at the 22nd percentile overall and 24th in the healthcare sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield of 32.61%, ranks at the 30th percentile in the covered equity universe and at the 48th percentile among its peers. Meanwhile, its annualized trailing 12-month volatility of 38.41%, falls at the 60th percentile in the universe and the 40th percentile in the healthcare sector.

### Fundamentals as of 26 Apr 2024

The earnings per share for Biotechnology Assets is 0.03. The company earns a return on invested capital of 16.55%, falling at the 92nd percentile in the healthcare sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Biotechnology Assets holds a price-to-earnings ratio of 13.02, a figure greater than 18% of its sector peers.





# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

## Other Definitions

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
