The Management Committee of the Barcelona Stock Exchange Indices has decided, in view of the special circumstances surrounding **Grupo Catalana Occidente**, **S.A.** (**GCO**) stock due to the Inoc, S.A. launched takeover bid, has decided, once the result of the offer has officially been published and pursuant to the Technical Regulations for the Composition and Calculation of Stock Exchanges Indices, **to exclude** the stock Grupo Catalana Occidente, S.A. (GCO) from the **BCN GLOBAL 100**, **BCN INDEXCAT** and **BCN MID-50** indices.

The BCN GLOBAL 100, BCN SERVICIOS FINANCIEROS, BCN INDEXCAT and BCN MID-50 indices adjustment will take place after close of trading on **December 8**<sup>th</sup> 2025.

These changes will be applied as from **December 9**th **2025**.
