

The Management Committee of the Bilbao Stock Exchange Indices has decided, in view of the special circumstances surrounding Mediaset España Comunicación, S.A. (TL5) stock, due to the next merger between MFE-MEDIAFOREUROPE N.V. and **Mediaset España Comunicación, S.A.**, and according to the Technical Regulations for the Composition and Calculation of Stock Exchanges Indices, to exclude the stock Mediaset España Comunicación, S.A. (TL5) from the **Bolsa Bilbao 2000 Index**, which will temporarily be composed of just 49 stocks.

The index adjustment will take place after **close of May 2nd**, the trading session before the merger is effective.

These changes will be applied as from **3th May** 2023.
