(AGIL)** stock due to the Valle Surf Bidco, S.L. launched takeover bid, has decided, once the result of the offer has officially been published and pursuant to the powers conferred in section 3.1.3.7 of the Technical Rules for the Composition and Calculation of the IBEX® Indices and Equity Strategy Indices managed by Sociedad de Bolsas, the adoption of the following special measures:

- The result of the Offer has been positive and acceptance level is over 90%.
- With effects as from **January 29<sup>th</sup>**, to **remove** the stock **Agile Content, S.A. (AGIL)** from the **IBEX GROWTH MARKET® ALL SHARE & IBEX GROWTH MARKET® 15** which will be temporarily composed by 14 stocks. The index adjustments will take place after close of trading on **January 28<sup>th</sup>**.
- In view of the fact that the Technical Advisory Committee will hold its next ordinary meeting on March 12<sup>th</sup>, the stock that replaces it will be decided and published on that date.
