Results of the Ordinary Review of the IBEX GROWTH MARKET® ALL SHARE and IBEX GROWTH MARKET® 15 Indices

At its follow up meeting on March 10th, the Technical Advisory Committee, in accordance with the Technical Regulations for the Composition and Calculation of the IBEX® Indexes and Strategy Indexes on Stocks administrated by Sociedad de Bolsas, has decided the following changes in IBEX GROWTH MARKET® Indices' constituents:

Following the exclusion of the stock **Atrys Health, S.A. (ATRY)** from the Index, due to the trading exclusion of all the Company's shares from the BME MTF Equity and their simultaneous admission to listing on the Stock Exchanges, as well as their inclusion in the Spanish Stock Exchange Interconnection System (SIBE) on February 7th 2022, the Committee has decided to substitute the said stock in the IBEX Growth Market® 15 Index which will thus be composed of 15 stocks again:
