Notice related to the stock Aedas Homes, S.A.

The Technical Advisory Committee, in view of the special circumstances surrounding **Aedas Homes, S.A (AEDAS)** stock due to the Neinor DMP BidCo, S.A.U. launched takeover bid, has decided, once the result of the offer has officially been published and pursuant to the powers conferred in section 3.1.3.7 of the Technical Rules for the Composition and Calculation of the IBEX® Indices and Equity Strategy Indices managed by Sociedad de Bolsas, the adoption of the following special measures:

- The result of the Offer has been positive and acceptance level is over 90%.
- With effects as from **March 9<sup>th</sup>**, **to remove** the stock Aedas Homes, S.A (AEDAS) from the **IBEX SMALL CAP®** and **IBEX TOP DIVIDENDO®** indices, which will be temporarily composed by 29 and 24 stocks, respectively. The index adjustments will take place after close of trading on **March 6<sup>th</sup>**.
- In view of the fact that the Technical Advisory Committee will hold its next follow up meeting on March 12<sup>th</sup>, the stock that replaces the excluded stock in IBEX SMALL CAP® index will be decided and published on that date.
