(BBVA) launched take-over bid, and once published the **negative outcome of the Offer**, which is rendered void, pursuant to the powers conferred in section 3.1.3.7 of the Technical Regulations for the Composition and Calculation of the IBEX® Indices and Strategy Indexes on Stocks administrated by Sociedad de Bolsas, has decided the following:

1. In relation to the constituents of the **IBEX 35®** and **IBEX 35® BANK indices**, to **maintain the current index composition**.
2. With respect to the **free float factor** to be applied depending on the Free Float of the affected stock, **no change** is to be made, in accordance to the section 3.1.2.2.b. of the Technical Regulations.
