The Technical Advisory Committee, in view of the special circumstances surrounding **Aedas Homes**, **S.A.** (**AEDAS**) stock due to the **NEINOR DMP BIDCO**, **S.A.** launched takeover bid, once the result of the offer has officially been published and pursuant to the powers conferred in section 3.1.3.7 of the Technical Rules for the Composition and Calculation of the IBEX® Indices and Equity Strategy Indices managed by Sociedad de Bolsas, and given that although the result of the Offer has been positive, the acceptance level has not reached the 90% threshold, has decided the adoption of the following special measure:

- To maintain the stock **Aedas Homes, S.A. (AEDAS)** as a constituent of **IBEX MEDIUM CAP**® and **IBEX TOP DIVIDENDO**®, with the applicable free float factor of 40% unchanged.
