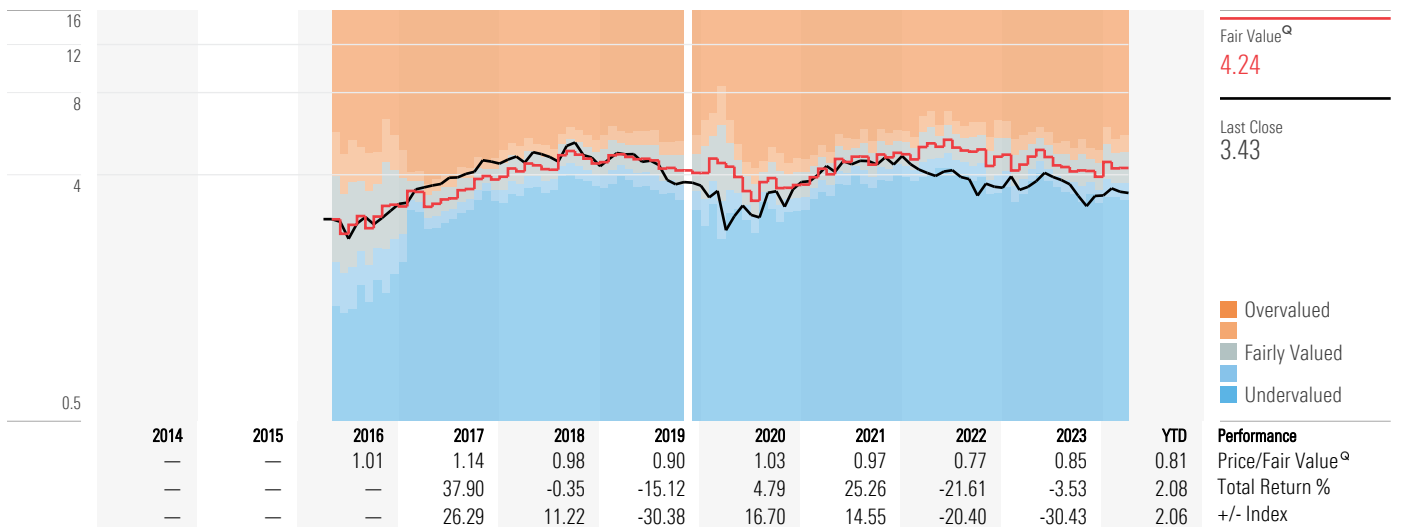

## Business Description

Global Dominion Access SA provides multi-technical services and engineering solutions. The company provides its services and solutions to telecom, banking, education, and the healthcare industry. Its business activity is functioned through two segments namely Multi-technological Services; and Solutions and Specialized Engineering segments. The group derives the majority of revenue from Multi-technological Services which is engaged in design, implementation, and maintenance of fixed and mobile telecommunications networks manages sales and distribution processes for telecommunications carriers, maintenance, repair and renovation services for industrial and energy firms.

Morningstar affirms a 4-star quantitative rating for Global Dominion Access. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

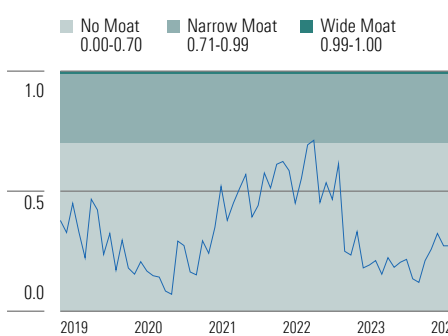
The stock's last closing price was 3.47, a discount of 17.91% to its Quantitative Fair Value estimate of 4.22. This discount has ranged between 26.65% and 11.3% over the past year. The stock's price to fair value ratio is at the 64th percentile in our global equity coverage universe for this methodology and at the 61st percentile relative to its peers in the technology sector.

## Economic Moat <sup>Q</sup> as of 1 Mar 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Global Dominion Access falls at the 34th percentile in the technology sector and at the 32nd in the equity coverage universe. The company has maintained its None quantitative moat rating for the last year. We also assign a Moderate quantitative financial health rating to Global Dominion Access. The company's raw score on this metric, termed Distance to Default, ranks at the 66th percentile overall and in the technology sector. Furthermore, this financial health rating most recently changed from Strong after 04/10/2023.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 58.76%, ranks at the 49th percentile in the covered equity universe and at the 69th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.17, falls at the 61st percentile in the universe and the 77th percentile in the technology sector.

Global Dominion Access furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating dates to after 01/01/2024, before which it was 3-star. Similarly, the firm's uncertainty rating changed from Very High to High after 01/18/2024.


We examine the financials and market statistics for Global Dominion Access to determine these ratings. Its earnings yield is 8.59% and its annualized trailing 12-month volatility is 19.67%. These fall at

The earnings per share for Global Dominion Access is 0.25. The company earns a return on invested capital of 7.8%, falling at the 65th percentile in the technology sector. The firm maintains a dividend yield of 2.85%. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Global Dominion Access holds a price-to-earnings ratio of 11.64, a figure greater than 17% of its sector peers. The company's price-to-free cash flow ratio is 5.58,

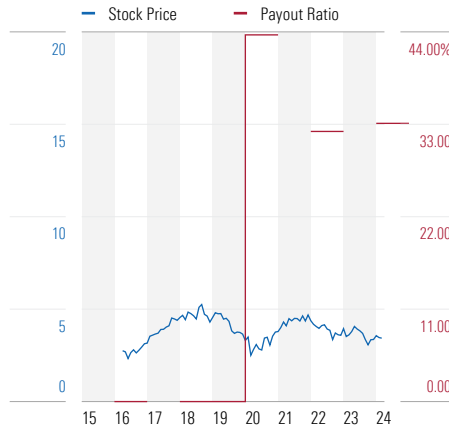

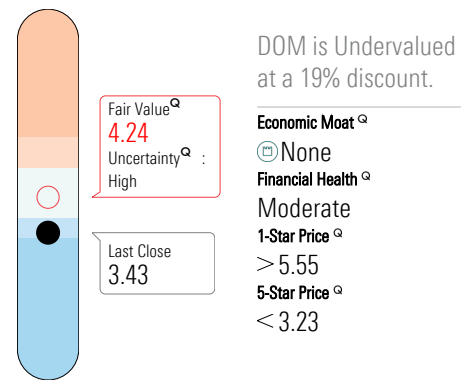

## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ### Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings").

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

**Low** – the interquartile range for possible fair values is less than 10%

**Medium** – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

**Weak** – assigned when Quantitative Financial Health < 0.2

**Moderate** – assigned when Quantitative Financial Health is between 0.2 and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.

**Fairly Valued – Last Price** is in line with Morningstar's quantitative fair value estimate.

**Fairly Valued – Last Price** is in line with Morningstar's quantitative fair value estimate.

**Overvalued – Last Price** is above Morningstar's quantitative fair value estimate.

**Sustainalytics ESG Risk Rating Assessment:** The ESG Risk Rating Assessment is provided by Sustainalytics; a Morningstar company. Sustainalytics' ESG Risk Ratings measure the degree to which company's economic value at risk is driven by environment, social and governance (ESG) factors.

Sustainalytics analyzes over 1,300 data points to assess a company's exposure to and management of ESG risks.
