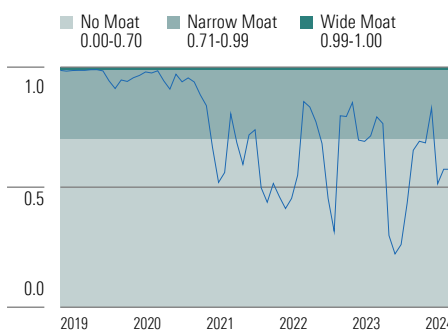

## Business Description

Prosegur Cash SA is engaged in the transit business and the outsourcing of services to financial institutions, retail establishments, government agencies and central banks, national mints, jewelers and other business activities around the world. The company's business lines can be categorized into Transport, Cash management, and New Products such as Automation of payments in shops using self-service cash machines, among others. The Business Divisions of the company are divided into three geographical segments: Europe, Asia-Oceania-Africa (AOA) and LatAm. The majority of the revenue is generated from the LatAm segment.

## Valuation <sup>Q</sup> as of 24 Apr 2024

Morningstar affirms a 3-star quantitative rating for Prosegur Cash. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 0.50, a discount of 9.01% to its Quantitative Fair Value estimate of 0.55. This discount has ranged between 24.76% and 5.81% over the past year. The stock's price to fair value ratio is at the 80th percentile in our global equity coverage universe for this methodology and at the 67th percentile relative to its peers in the industrials sector.

Prosegur Cash furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating dates to after 12/13/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Very High to High after 03/01/2024.

We examine the financials and market statistics for Prosegur Cash to determine these ratings. Its earnings yield is 8.04% and its annualized trailing 12-month volatility is 18.43%. These fall at the 79th and 17th percentiles in the equity universe and at

the 77th and 17th in the industrials sector, respectively.

## Economic Moat <sup>Q</sup> as of 24 Apr 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.56 sits at the 51st percentile in the industrials sector. This is a decrease from 0.86, the maximum of its moat scores over the past year.

The quantitative financial health rating for Prosegur Cash is Moderate. Its financial health score, termed Distance to Default, sits at the 47th percentile in the universe and 46th percentile in the sector.

The significant drivers of these ratings are the company's sales yield and enterprise value-to-market value ratio. The sales yield for Prosegur Cash is 253.10%, and its enterprise value-to-market value ratio is 2.01. They sit at the 86th and 87th percentile in the global equity universe, respectively.

## Fundamentals as of 24 Apr 2024

Prosegur Cash maintains earnings per share of 0.04. The company further earns a return on invested capital of 7.21%. The shares offer a dividend yield of 4.12%. These values are calculated over a trailing 12-month period.

As of last market close, Prosegur Cash has a price-to-earnings ratio of 12.44, falling below the 32nd percentile in its sector (where a lower percentile means a lower ratio) and ranging between 7.58 and 12.45 over the past year. The company's price-to-free cash flow ratio is 5.77, falling at the 18th percentile in its sector and ranging between 4.29 and 5.97 over the past year.

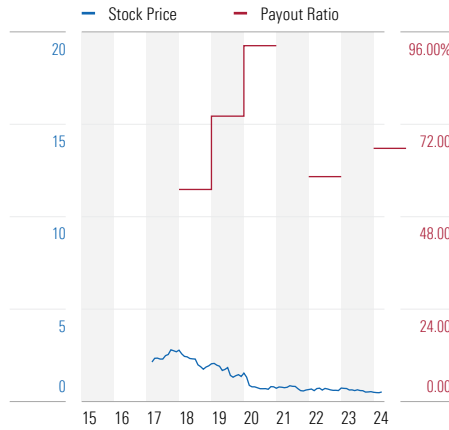



## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings").

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

**Low** – the interquartile range for possible fair values is less than 10%

**Medium** – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

**Weak** – assigned when Quantitative Financial Health < 0.2

**Moderate** – assigned when Quantitative Financial Health is between 0.2 and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.
