


### **Business Description**

Neinor Homes SA is a residential property development company in Spain. The company is engaged in developing and selling property developments. Its operating segment includes Rentals, Development, Asset Management and others. The company generates maximum revenue from the Development segment.

### Valuation <sup>°</sup>as of 30 Apr 2024

Neinor Homes achieves a 4-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 13.09, above the previous closing price of 10.48. The stock has been trading between a 33.76% and 8.25% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 60th percentile in the coverage universe and 70th percentile in the real estate sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Neinor Homes is High.

Our quantitative star rating last differed from the current rating on 04/04/2024; the uncertainty rating last differed on 04/04/2024. The previous ratings were 3 and Very High, respectively.

The main driver of the company's valuation and uncertainty is its earnings yield. The earnings yield of 11.60% falls at the 88th percentile in the equity universe and 84th in its sector.

### Economic Moat <sup>@</sup>as of 30 Apr 2024

Quantitatively, we do not believe Neinor Homes has an economic moat. Its moat score of 0.16 corresponds to the 27th percentile in the real estate sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.33 in this period (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 52nd percentile overall and the 64th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and enterprise value-to-market value ratio. The book value yield is 124.93%, sitting at the 55th percentile in the real estate sector. The company's enterprise value-to-market value ratio is 1.27, corresponding to the 68th percentile in the equity coverage universe and the 28th percentile in the sector.

#### Fundamentals as of 30 Apr 2024

Neinor Homes reports earnings per share of 1.22. Its return on invested capital is 7.61%. The company maintains a dividend yield of 9.85%, paying out 38.73% of earnings. These values are calculated over a trailing 12-month period.

As of last market close, Neinor Homes has a priceto-earnings ratio of 8.62, falling at the 26th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 6.75 and 13.53 over the past year. The company's priceto-free cash flow ratio is 79.03, falling at the 94th percentile in its sector and ranging between 2.25 and 80.54 over the past year.



## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analystdriven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. **Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

 $Very\ High\ -$  the interquartile range for possible fair values is less than 80% but greater than 35%

 $\ensuremath{\textit{Extreme}}\xspace -$  the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.

Farily Valued – Last Price is in line with Morningstar's quantitative fair value estimate.
