



Business Description

Soltec Power Holdings SA is specialized in providing integrated solutions in solar PV energy. The company designs, manufactures and installs solar tracking systems and develops solar power projects. Its business is divided into industrial (trackers and construction services) business line, which is also referred to as Soltec Industrial, and project development business line, which is also referred to as Powertis. It offers a portfolio of solar trackers, including the SF8 and SF7 single-axis trackers, the SF8 and SF7 bi-facial trackers and the SF7 Tandem

Valuation ^Qas of 1 May 2024

Morningstar affirms a 3-star quantitative rating for Soltec Power Holdings. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 2.28, a discount of 35.39% to its Quantitative Fair Value estimate of 3.52. This discount has ranged between 53.58% and 23.04% over the past year. The stock's price to fair value ratio is at the 32nd percentile in our global equity coverage universe for this methodology and at the 29th percentile relative to its peers in the technology sector.

Soltec Power Holdings furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating dates to after 10/20/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Extreme to Very High after 12/26/2023.

We examine the financials and market statistics for Soltec Power Holdings to determine these ratings. Its enterprise value-to-market value ratio is 2.02 and its annualized trailing 12-month volatility is 37.88%. These fall at the 87th and 59th percentiles in the equity universe and at the 93rd and 51st in

the technology sector, respectively.

Economic Moat as of 1 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.11 sits at the 11th percentile in the technology sector. This is a decrease from 0.65, the maximum of its moat scores over the past year.

The quantitative financial health rating for Soltec Power Holdings is Moderate. Its financial health score, termed Distance to Default, sits at the 15th percentile in both the universe and sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Soltec Power Holdings is 72.39%, and its annualized trailing 12-month volatility is 37.88%. They sit at the 58th and 59th percentile in the global equity universe, respectively.

Fundamentals as of 1 May 2024

The earnings per share for Soltec Power Holdings is 0.09. The company earns a return on invested capital of 3.32%, falling at the 48th percentile in the technology sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Soltec Power Holdings holds a price-to-earnings ratio of 24.2, a figure greater than 48% of its sector peers.






Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

- ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
