



#### **Business Description**

A renewables developer, Acciona Energia was spun off from Spanish industrial conglomerate Acciona in July 2021. The floating share is 17.3%. At the end of 2023, the group had 12.1 gigawatts of consolidated capacity. 70% of Acciona Energia's capacity is onshore wind, nearly 7% is hydro dams in Spain and 18% is solar photovoltaic. Geographically, 44% of the capacity are located in Spain. The three biggest markets outside Spain are Mexico, the US, and Australia.

## Valuation as of 17 May 2024

Morningstar affirms a 3-star quantitative rating for Corporacion Acciona. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 22.26, a discount of 13.23% to its Quantitative Fair Value estimate of 25.65. This discount has ranged between 36.35% and 8.84% over the past year. The stock's price to fair value ratio is at the 68th percentile in our global equity coverage universe for this methodology and at the 54th percentile relative to its peers in the utilities sector.

Corporacion Acciona furthermore holds a Medium quantitative uncertainty rating.

The company's quantitative star rating dates to after 07/28/2023, before which it was 4-star. Similarly, the firm's uncertainty rating changed from High to Medium after 05/09/2024.

We examine the financials and market statistics for Corporacion Acciona to determine these ratings. Its earnings yield is 7.19% and falls at the 77th percentile in the equity universe and at the 70th percentile in the utilities sector.

## Economic Moat <sup>Q</sup> as of 17 May 2024

Quantitatively, we do not believe Corporacion Ac-

ciona has an economic moat. Its moat score of 0.24 corresponds to the 20th percentile in the utilities sector. Furthermore, this rating last differed from its previous rating of Narrow on 04/01/2024, when the company's moat score fell from its maximum of 0.87 (score of 1 indicates greatest economic moat). The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 34th percentile overall and the 36th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and annualized trailing 12-month volatility. The book value yield is 81.08%, sitting at the 63rd percentile in the utilities sector. The company's annualized trailing 12-month volatility is 27.37%, corresponding to the 39th percentile in the equity coverage universe and the 56th percentile in the sector.

### Fundamentals as of 17 May 2024

Corporacion Acciona maintains earnings per share of 1.6. The company further earns a return on invested capital of 6.41%. The shares offer a dividend yield of 3.67%. These values are calculated over a trailing 12-month period.

As of last market close, Corporacion Acciona has a price-to-earnings ratio of 13.91, falling below the 41st percentile in its sector (where a lower percentile means a lower ratio) and ranging between 9.78 and 16.17 over the past year.



# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. # **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
