



#### **Business Description**

Amper SA engages in the research, development, manufacture, marketing, engineering, installation, and maintenance of telecommunication and electronic systems and equipment, and related components.

### Valuation as of 1 May 2024

Morningstar affirms a 3-star quantitative rating for Amper. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 0.10, a discount of 24.9% to its Quantitative Fair Value estimate of 0.14. This discount has ranged between 50.28% and 23.27% over the past year. The stock's price to fair value ratio is at the 50th percentile in our global equity coverage universe for this methodology and at the 47th percentile relative to its peers in the technology sector.

Amper furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Extreme to Very High after 01/03/2024.

We examine the financials and market statistics for Amper to determine these ratings. Its enterprise value-to-market value ratio is 1.52 and its trailing 12-month maximum drawdown is 33.97%. These fall at the 78th and 58th percentiles in the equity universe and at the 89th and 49th in the technology sector, respectively.

### Economic Moat as of 1 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.23 sits at the 23rd percentile in the technology sector. This is a decrease from 0.35, the

maximum of its moat scores over the past year.

The quantitative financial health rating for Amper is Moderate. Its financial health score, termed Distance to Default, sits at the 25th percentile in the universe and 24th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Amper is 48.69%, and its annualized trailing 12-month volatility is 32.29%. They sit at the 43rd and 50th percentile in the global equity universe, respectively.

### Fundamentals as of 1 May 2024

Amper maintains breakeven earnings per share. The company further earns a return on invested capital of 4.09%. These values are calculated over a trailing 12-month period.

As of last market close, Amper has a price-to-earnings ratio of 588.57, falling below the 95th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 41.12 and 593.14 over the past year.





## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
