



Business Description

Deoleo SA is primarily engaged in the food processing sector. It produces olive oil, rice, table olives, vinegars, mayonnaise, mustards, ketchup, flour, and dates. In addition, it also produces byproducts of olive oil processing that are used by cosmetics and health food producers. Geographically, the activities are functioned through the region of Spain and it derives revenue from the sale of products.

Valuation ^Qas of 2 May 2024

Morningstar affirms a 3-star quantitative rating for Deoleo. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 0.22, a discount of 38.21% to its Quantitative Fair Value estimate of 0.35. This discount has ranged between 49.48% and 28.36% over the past year. The stock's price to fair value ratio is at the 28th percentile in our global equity coverage universe for this methodology and at the 25th percentile relative to its peers in the consumer defensive sector.

Deoleo furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Extreme to Very High after 04/03/2024.

We examine the financials and market statistics for Deoleo to determine these ratings. Its enterprise value-to-market value ratio is 2.30 and its trailing 12-month maximum drawdown is 26.59%. These fall at the 89th and 45th percentiles in the equity universe and at the 90th and 55th in the consumer defensive sector, respectively.

Quantitatively, we do not believe Deoleo has an economic moat. Its moat score of 0.15 corresponds to the 10th percentile in the consumer defensive sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.18 in this period (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 43rd percentile overall and the 38th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and enterprise value-to-market value ratio. The book value yield is 218.17%, sitting at the 93rd percentile in the consumer defensive sector. The company's enterprise value-to-market value ratio is 2.30, corresponding to the 89th percentile in the equity coverage universe and the 90th percentile in the sector.

Fundamentals as of 2 May 2024

Deoleo maintains losses per share of -0.04. The company further earns a return on invested capital of -1.56%. These values are calculated over a trailing 12-month period.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
