



Business Description

Bodegas Riojanas SA is a Spain-based company which engages in winemaking. It engaged in the production and distribution of wine. It also sells its products online. The major brands are Vina Albina, Monte Real, and Puerta Vieja.

Valuation as of 30 Nov 2024

Bodegas Riojanas achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 5.33, above the previous closing price of 3.32. The stock has been trading between a 47.03% and 28.18% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 23rd percentile in the coverage universe and 18th percentile in the consumer defensive sector.

The quantitative uncertainty rating for Bodegas Riojanas is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 11/28/2024, when it was Extreme.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and drawdown. The enterprise value-to-market value ratio of 2.29 falls at the 89th percentile in the equity universe and the 91st percentile in its sector. The trailing 12-month maximum drawdown of 28.76% corresponds to the 48th percentile overall and the 60th percentile in the industry.

Economic Moat ^Q as of 29 Nov 2024

Quantitatively, we do not believe Bodegas Riojanas has an economic moat. Its moat score of 0.62 corresponds to the 50th percentile in the consumer defensive sector. Furthermore, this rating last differed from its previous rating of Narrow on 11/

20/2024, when the company's moat score fell from its maximum of 0.8 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 31st percentile overall and the 28th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and annualized trailing 12-month volatility. The book value yield is 127.59%, sitting at the 83rd percentile in the consumer defensive sector. The company's annualized trailing 12-month volatility is 26.44%, corresponding to the 34th percentile in the equity coverage universe and the 48th percentile in the sector.

Fundamentals as of 30 Nov 2024

The earnings per share for Bodegas Riojanas is -0.02. The company earns a return on invested capital of 0.79%, falling at the 20th percentile in the consumer defensive sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.

Examining valuation further, the company's priceto-free cash flow ratio is 4.71, greater than 13% of its sector peers. These values are calculated using the stock's price at last market close.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%

The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
