



#### **Business Description**

Corporacion Financiera Alba SA is an investment holding company in Spain. The company's objective is to take long-term holdings in listed and unlisted companies, with activities in different economic sectors. The company is a part of the March group which integrates Banca March and Fundacion Juan March. Banca March is a family-owned Spanish bank, focused on Private Banking and Wealth Management, with a strong focus on family businesses. Its investments include top-tier office buildings in prime downtown and suburban business locations. Its current investment portfolio includes Acerinox, Naturgy, CIE Automotive, Ebro, Indra, Viscofan among others. It is also engaged in the lease of properties and holds interests in companies through venture capital.

### Valuation <sup>Q</sup>as of 17 May 2024

Corporacion Financiera achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 56.50, above the previous closing price of 50.30. The stock has been trading between a 23.42% discount and 9.19% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 73rd percentile in the coverage universe and 68th percentile in the financial services sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Corporacion Financiera is Very High.

Our quantitative star rating last differed from the current rating on 07/04/2023; the uncertainty rating last differed on 05/15/2024. The previous ratings were 4 and High, respectively.

The main drivers of the company's valuation and uncertainty are its earnings yield and drawdown.

The earnings yield of 12.96% falls at the 91st percentile in the equity universe and the 81st percentile in its sector. The trailing 12-month maximum drawdown of 8.06% corresponds to the 6th percentile overall and the 14th percentile in the industry.

## Economic Moat <sup>Q</sup> as of 17 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.87 sits at the 83rd percentile in the financial services sector. This is a decrease from 0.93, the maximum of its moat scores over the past year.

The quantitative financial health rating for Corporacion Financiera is Strong. Its financial health score, termed Distance to Default, sits at the 95th percentile in both the universe and sector.

The significant drivers of these ratings are the company's sales yield and annualized trailing 12-month volatility. The sales yield for Corporacion Financiera is 18.22%, and its annualized trailing 12-month volatility is 13.21%. They sit at the 24th and 7th percentile in the global equity universe, respectively.

#### Fundamentals as of 17 May 2024

The earnings per share for Corporacion Financiera is 6.52. The firm maintains a dividend yield of 2.02%. We calculate the above figures over a trailing 12-month period.


Examining valuation further, we find Corporacion Financiera holds a price-to-earnings ratio of 7.71, a figure greater than 25% of its sector peers. The company's price-to-free cash flow ratio is 33.56, greater than 86% of its sector peers. These values are calculated using the stock's price at last market close.

# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. As an employee of Morningstar, Inc., Mr. Davidson is guided by Morningstar, Inc.'s Code of Ethics and Personal Securities Trading Policy in carrying out his responsibilities.

### **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

- iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$  – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
