



Business Description

General de Alquiler de Maquinaria SA is a machinery rental company. The company's rental fleet includes compactors, compressors, dumpers, electric machinery, platforms, cranes, scaffolds and transport vehicles, as well as auxiliary equipment and machinery used in the infrastructure, agricultural, port, construction, industrial and energy sectors. In addition, the company is involved in the sale of second-hand equipment.

Valuation as of 17 May 2024

General de Alquiler achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 1.78, above the previous closing price of 1.42. The stock has been trading between a 31.96% and 10.63% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 53rd percentile in the coverage universe and 36th percentile in the industrials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for General de Alquiler is Very High.

Our quantitative star rating last differed from the current rating on 06/05/2023; the uncertainty rating last differed on 05/15/2024. The previous ratings were 4 and High, respectively.

The main drivers of the company's valuation and uncertainty are its earnings yield and drawdown. The earnings yield of 6.36% falls at the 73rd percentile in the equity universe and the 70th percentile in its sector. The trailing 12-month maximum drawdown of 20.27% corresponds to the 31st percentile overall and the 36th percentile in the industry.

Economic Moat ^Q as of 17 May 2024

Quantitatively, we do not believe General de Alquiler has an economic moat. Its moat score of 0.31 corresponds to the 27th percentile in the industrials sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.55 in this period (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 25th percentile overall and the 23rd percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and annualized trailing 12-month volatility. The book value yield is 73.35%, sitting at the 65th percentile in the industrials sector. The company's annualized trailing 12-month volatility is 27.34%, corresponding to the 39th percentile in the equity coverage universe and the 45th percentile in the sector.

Fundamentals as of 17 May 2024


The earnings per share for General de Alquiler is 0.09. The company earns a return on invested capital of 4.07%, falling at the 36th percentile in the industrials sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.


Examining valuation further, we find General de Alquiler holds a price-to-earnings ratio of 15.72, a figure greater than 41% of its sector peers. The company's price-to-free cash flow ratio is 10.09, greater than 32% of its sector peers. These values are calculated using the stock's price at last market close.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
