



Business Description

Innovative Solutions Ecosystem SA provides innovative solutions in the areas of data management and security, cryptography and related applications, and other technologies that facilitate data security and the communication of organizations with customers and stakeholders.

Valuation as of 17 May 2024

Morningstar maintains a 3-star quantitative star rating for Innovative Solutions, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.57, below our quantitative fair value estimate of 0.62. These shares have traded between a 43.31% discount and 5.22% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 79th percentile; in the industrials sector, the firm's score lies at the 68th percentile (meaning the shares are more undervalued than 68% of stocks in the sector).

Furthermore, Innovative Solutions maintains a quantitative valuation uncertainty rating of Extreme.

The company has held this star rating over the past year. The uncertainty rating for Innovative Solutions has remained Extreme since the previous rating of Very High, which was last assigned on 02/09/2024.

The key factors behind these ratings are the company's EV-MV ratio and drawdown. The enterprise value-to-market value ratio is 1.34, and its maximum trailing 12-month maximum drawdown is 14.99%. The EV-MV ratio falls at the 71st percentile in the industrials sector while the drawdown is at the 5th percentile. Over the past year, the company's EV-MV ratio has been between 1.34 and 1.35; its drawdown has ranged between 0.00% and

14.99%.

Economic Moat ^Q as of 27 Feb 2023

Quantitatively, we believe Innovative Solutions has a Narrow economic moat. Its moat score of 0.92 corresponds to the 85th percentile in the industrials sector. Furthermore, this rating has not changed over the past year, while the company's moat score fell from its maximum of 0.98 in this period (score of 1 indicates greatest economic moat)

The company also maintains a quantitative financial health rating of Strong. Its score sits at the 77th percentile overall and the 79th percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and enterprise value-to-market value ratio. The book value yield is -23.95%, sitting below the 5th percentile in the industrials sector. The company's enterprise value-to-market value ratio is 1.34, corresponding to the 72nd percentile in the equity coverage universe and the 71st percentile in the sector.

Fundamentals as of 17 May 2024

Innovative Solutions maintains losses per share of 0.09. We do not have enough information to report on the company's return-on-invested-capital and dividend yield.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
