



#### **Business Description**

Inmobiliaria del Sur, S.A. along with its subsidiaries is engaged in the real estate industry. The company constructs and sells houses; develops and rents various offices and commercial premises to third parties; and rents car parks. It is also involved in the real estate management business.

## Valuation <sup>Q</sup>as of 1 May 2024

Morningstar maintains a 4-star quantitative star rating for Inmobiliaria del Sur, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 7.46, below our quantitative fair value estimate of 9.19. These shares have traded between a 24.11% and 12.96% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 61st percentile; in the real estate sector, the firm's score lies at the 71st percentile (meaning the shares are more undervalued than 71% of stocks in the sector).

Furthermore, Inmobiliaria del Sur maintains a quantitative valuation uncertainty rating of High.

The company has held this star rating since the previous rating of 3, which was last assigned on 04/16/2024. The uncertainty rating for Inmobiliaria del Sur has remained High since the previous rating of Very High, which was last assigned on 03/28/2024.

The key factors behind these ratings are the company's earnings yield and volatility. The earnings yield is 8.03%, and its maximum annualized trailing 12-month volatility is 22.07%. The earnings yield falls at the 77th percentile in the real estate sector while the volatility is at the 32nd percentile. Over the past year, the company's earnings yield has been between 8.03% and 17.01%; its volatility has ranged between 18.76% and 22.07%.

### Economic Moat as of 1 May 2024

Quantitatively, we do not believe Inmobiliaria del Sur has an economic moat. Its moat score of 0.64 corresponds to the 68th percentile in the real estate sector. Furthermore, this rating last differed from its previous rating of Narrow on 11/23/2023, when the company's moat score fell from its maximum of 0.71 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 41st percentile overall and the 51st percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its book value yield and enterprise value-to-market value ratio. The book value yield is 101.74%, sitting at the 40th percentile in the real estate sector. The company's enterprise value-to-market value ratio is 2.63, corresponding to the 91st percentile in the equity coverage universe and the 74th percentile in the sector.

## Fundamentals as of 1 May 2024

The earnings per share for Inmobiliaria del Sur is 0.61. The company earns a return on invested capital of 4.12%, falling at the 67th percentile in the real estate sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.





# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
