



Business Description

Lingotes Especiales SA engages in the design, development, casting, machining, and assembly of grey and ductile iron components primarily for the automobile industry. The company is also involved in the machining and assembly of automotive components, primarily brake discs and drums, flywheels, or pressure-plates; and provision of finishing services, and coating and other additions to components used in automation industry. It also serves electrical appliances, railways, civil engineering, industrial vehicle, farm machinery, compressor, and other markets.

Valuation as of 4 May 2024

Lingotes Especiales achieves a 4-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 9.75, above the previous closing price of 6.74. The stock has been trading between a 47.68% and 21.38% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 38th percentile in the coverage universe and 47th percentile in the consumer cyclical sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Lingotes Especiales is Very High.

Our quantitative star rating last differed from the current rating on 04/02/2024; the uncertainty rating last differed on 04/17/2024. The previous ratings were 3 and High, respectively.

The main drivers of the company's valuation and uncertainty are its sales yield and drawdown. The sales yield of 143.61% falls at the 76th percentile in the equity universe and the 57th percentile in its sector. The trailing 12-month maximum drawdown of 25.83% corresponds to the 43rd percentile over-

all and the 44th percentile in the industry.

Economic Moat as of 6 May 2024

With a Morningstar quantitative moat rating of None, the quantitative moat score for Lingotes Especiales falls at the 60th percentile in the consumer cyclical sector and at the 54th in the equity coverage universe. The company has maintained its None quantitative moat rating for the last year. We also assign a Moderate quantitative financial health rating to Lingotes Especiales. The company's raw score on this metric, termed Distance to Default, ranks at the 50th percentile overall and 56th in the consumer cyclical sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 68.29%, ranks at the 56th percentile overall and among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.22, falls at the 66th percentile in the universe and the 53rd percentile in the consumer cyclical sector.

Fundamentals as of 4 May 2024


Lingotes Especiales maintains earnings per share of 0.32. The company further earns a return on invested capital of 5.07%. The shares offer a dividend yield of 5.93%. These values are calculated over a trailing 12-month period.

As of last market close, Lingotes Especiales has a price-to-earnings ratio of 21.06, falling below the 57th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 11.77 and 27.06 over the past year. The company's price-to-free cash flow ratio is 7.59, falling at the 29th percentile in its sector and ranging between 6.99 and 101.88 over the past year.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
