



Business Description

Duro Felguera SA is a Spain based company engaged in executing turnkey projects for the energy, industrial and oil and gas sectors. It supplies specialized services for industries and manufactures capital goods. The company is involved in carrying out integrated projects for the construction of power generation plants, mineral treatment and bulk-handling facilities, fuel storage plants and other facilities and installations for the oil and gas industry. In the services area, the organization specializes in the erection of energy and industrial facilities. The business segments of the group are Energy; Mining and Handling; Oil and Gas; Services; Manufacturing of capital goods; and Communications

Valuation as of 3 May 2024

Duro Felguera achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 0.64, above the previous closing price of 0.55. The stock has been trading between a 44.1% and 0.5% discount to its quantitative fair value over the past year. The stock's current valuation rating sits at the 68th percentile in the coverage universe and 52nd percentile in the industrials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Duro Felquera is Very High.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 02/28/2024, when it was High.

The main drivers of the company's valuation and uncertainty are its earnings yield and drawdown. The earnings yield of 7.87% falls at the 79th percentile in the equity universe and the 76th percent-

ile in its sector. The trailing 12-month maximum drawdown of 28.18% corresponds to the 48th percentile overall and the 55th percentile in the industry.

Economic Moat ^Qas of 3 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.53 sits at the 46th percentile in the industrials sector. This is a decrease from 0.8, the maximum of its moat scores over the past year.

The quantitative financial health rating for Duro Felguera is Moderate. Its financial health score, termed Distance to Default, sits at the 37th percentile in the universe and 36th percentile in the sector.

The significant drivers of these ratings are the company's enterprise value and enterprise value-to-market value ratio. The enterprise value for Duro Felguera is 251.39 million, and its enterprise value-to-market value ratio is 2.00. They sit at the 50th and 87th percentile in the global equity universe, respectively.

Fundamentals as of 3 May 2024

Duro Felguera maintains earnings per share of 0.06. We do not have enough information to report on the company's return-on-invested-capital and dividend yield.

As of last market close, Duro Felguera has a priceto-earnings ratio of 12.7, falling below the 32nd percentile in its sector (where a lower percentile means a lower ratio) and ranging between 1.99 and 17.17 over the past year.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$ — the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
