



#### **Business Description**

Miquel y Costas & Miquel SA is operating in the paper industry. The principal line of business is the manufacturing and distribution of fine and specialty lightweight papers, with the main specialization being cigarette papers. Its product portfolio consists of rolling papers, printing papers, specialty papers and textile pulps. The company's products are distributed both domestically and abroad.

### Valuation as of 3 May 2024

Morningstar maintains a 3-star quantitative star rating for Miquel y Costas & Miquel, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 11.35, below our quantitative fair value estimate of 12.79. These shares have traded between a 19.88% and 4.04% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 75th percentile; in the basic materials sector, the firm's score lies at the 87th percentile (meaning the shares are more undervalued than 87% of stocks in the sector).

Furthermore, Miquel y Costas & Miquel maintains a quantitative valuation uncertainty rating of High.

The company has held this star rating since the previous rating of 4, which was last assigned on 12/14/2023. The uncertainty rating for Miquel y Costas & Miquel has remained High since the previous rating of Very High, which was last assigned on 05/01/2024.

The key factors behind these ratings are the company's earnings yield and volatility. The earnings yield is 8.72%, and its maximum annualized trailing 12-month volatility is 18.89%. The earnings yield falls at the 88th percentile in the basic materials sector while the volatility is at the 6th percentile. Over the past year, the company's earnings yield

has been between 6.57% and 9.34%; its volatility has ranged between 15.85% and 18.89%.

### Economic Moat <sup>Q</sup> as of 3 May 2024

Quantitatively, we believe Miquel y Costas & Miquel has a Narrow economic moat. Its moat score of 0.76 corresponds to the 87th percentile in the basic materials sector. Furthermore, this rating last differed from its previous rating of None on 05/01/2024, when the company's moat score fell from its maximum of 0.83 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Strong. Its score sits at the 84th percentile overall and the 93rd percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its return on assets and annualized trailing 12-month volatility. The return on assets is 8.20, sitting at the 88th percentile in the basic materials sector. The company's annualized trailing 12-month volatility is 15.91%, corresponding to the 11th percentile in the equity coverage universe and the 6th percentile in the sector.

### Fundamentals as of 3 May 2024


Miquel y Costas & Miquel maintains earnings per share of 0.99. The company further earns a return on invested capital of 9.62%. The shares offer a dividend yield of 3.93%. These values are calculated over a trailing 12-month period.

As of last market close, Miquel y Costas & Miquel has a price-to-earnings ratio of 11.46, falling below the 31st percentile in its sector (where a lower percentile means a lower ratio) and ranging between 10.61 and 15.22 over the past year. The company's price-to-free cash flow ratio is 64.72, falling at the

# **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

- iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$  — the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
