


Business Description

Grupo Empresarial San Jose SA is a holding company. It constructs hospitals, buildings and facilities, energy power plants, and infrastructure projects, as well as conserves parks and gardens; and undertakes civil, and engineering and industrial construction works. The company also researches and develops energy efficiency and renewable energy projects; and provides consultancy and project management services for real estate management, technology, and development projects.

Valuation as of 17 May 2024

Morningstar maintains a 3-star quantitative star rating for Grupo Empresarial San, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 4.61, below our quantitative fair value estimate of 5.20. These shares have traded between a 30.3% and 5.08% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 72nd percentile; in the industrials sector, the firm's score lies at the 58th percentile (meaning the shares are more undervalued than 58% of stocks in the sector).

Furthermore, Grupo Empresarial San maintains a quantitative valuation uncertainty rating of High. The company has held this star rating since the previous rating of 4, which was last assigned on 12/04/2023. The uncertainty rating for Grupo Empresarial San has remained High since the previous rating of Very High, which was last assigned on 04/01/2024.

The key factors behind these ratings are the company's earnings yield and volatility. The earnings yield is 6.72%, and its maximum annualized trailing 12-month volatility is 25.98%. The earnings yield

falls at the 72nd percentile in the industrials sector while the volatility is at the 28th percentile. Over the past year, the company's earnings yield has been between 6.40% and 8.30%; its volatility has ranged between 15.99% and 25.98%.

Economic Moat ^Q as of 17 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.52 sits at the 49th percentile in the industrials sector. This is a decrease from 0.69, the maximum of its moat scores over the past year.

The quantitative financial health rating for Grupo Empresarial San is Strong. Its financial health score, termed Distance to Default, sits at the 95th percentile in both the universe and sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12-month volatility. The book value yield for Grupo Empresarial San is 60.51%, and its annualized trailing 12-month volatility is 22.14%. They sit at the 52nd and 26th percentile in the global equity universe, respectively.

Fundamentals as of 17 May 2024


The earnings per share for Grupo Empresarial San is 0.31. The company earns a return on invested capital of 7.33%, falling at the 56th percentile in the industrials sector. The firm maintains a dividend yield of 2.46%. We calculate the above figures over a trailing 12-month period.

Examining valuation further, we find Grupo Empresarial San holds a price-to-earnings ratio of 14.87, a figure greater than 39% of its sector peers. The company's price-to-free cash flow ratio is 3.06, greater than 6% of its sector peers. These values are calculated using the stock's price at last market close.

Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Given the nature of the quantitative report and the quantitative ratings, there is no one analyst in which a given report is attributed to; however, Mr. Lee Davidson, Head of Quantitative Research for Morningstar, Inc., is responsible for overseeing the methodology that supports the quantitative equity ratings used in this report. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

- iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

 $\bar{\text{\textbf{High}}}$ — the interquartile range for possible fair values is less than 35% but greater than 15%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
