

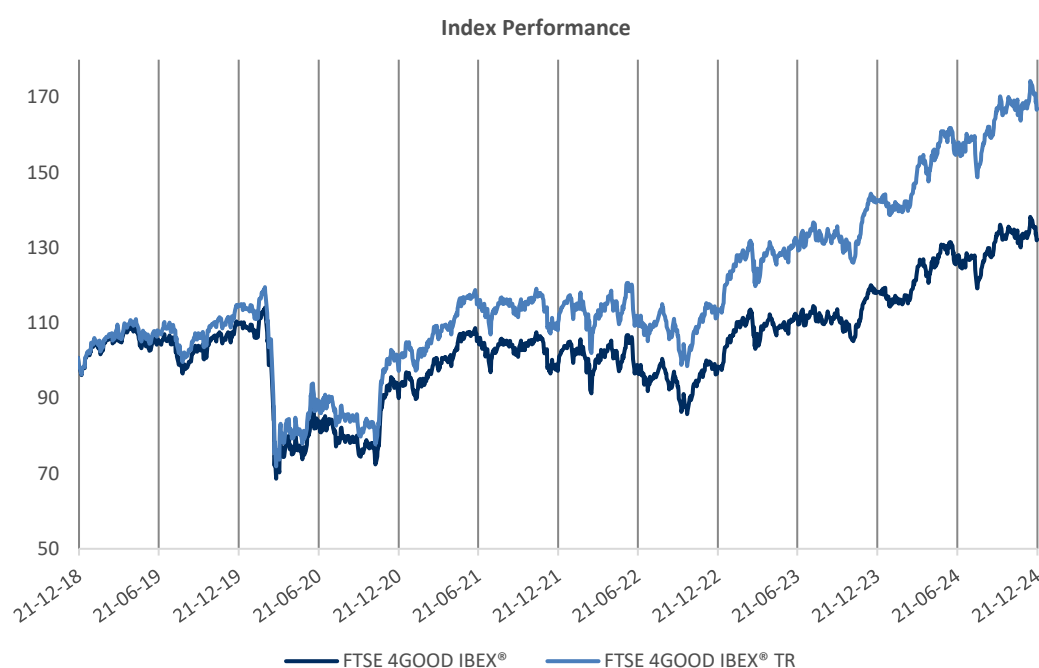

### FTSE 4GOOD IBEX® Index

#### Index Description

Bolsas y Mercados Españoles (BME) calculates, publishes and disseminates in real-time the IBEX Index. BME, the company that integrates the principal securities markets and financial systems in Spain, is Europe's fifth biggest exchange operator by equity turnover according to data from FESE. The equity turnover for December was 23.781 billion euros and the number of trades amounted to 2.114 million.

FTSE 4GOOD IBEX® is a tradable index suitable for investment products. The index is a tool for investors seeking to invest in companies that demonstrate good sustainability practices. It also supports investors that wish to encourage positive change in corporate behavior and align their portfolios with their values.

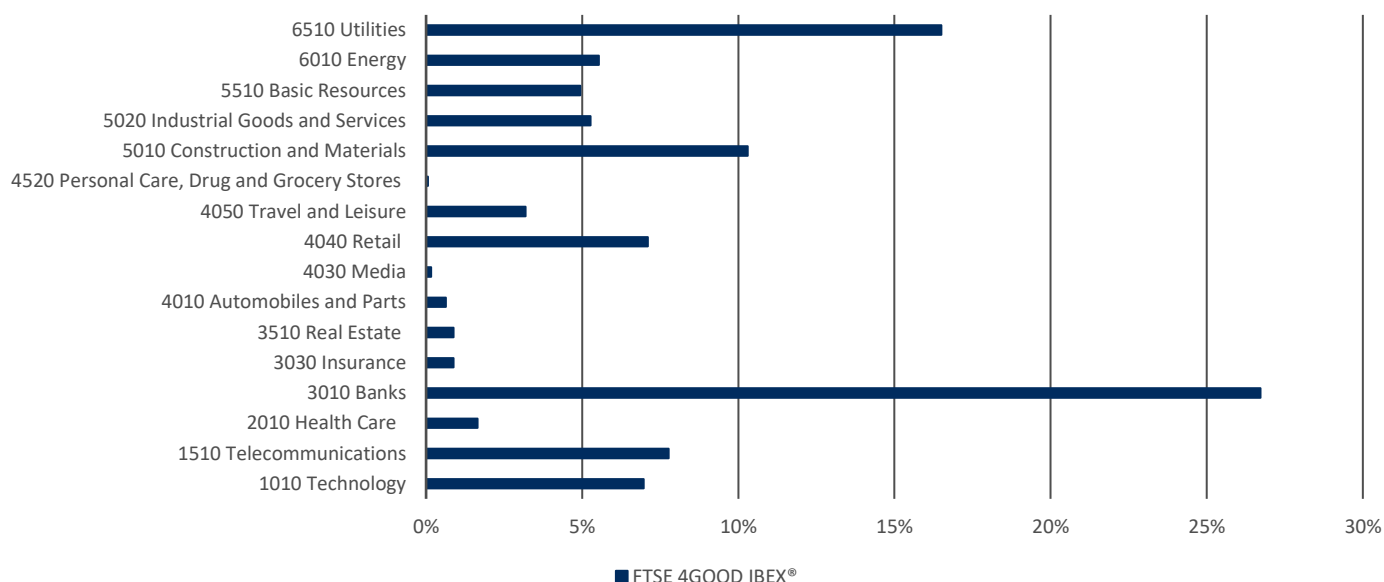

## Index Methodology

The index comprises companies in the BME's IBEX 35 Index and the FTSE Spain All Cap Index that demonstrate good sustainability practices. Companies need to meet a variety of environmental, social and governance criteria to meet the inclusion requirements. The FTSE4Good selection criteria are designed to reflect strong ESG risk management practices.

Criteria are developed using an extensive market consultation process and are approved by an independent committee of experts. A broad range of stakeholders help shape the criteria, including NGOs, governmental bodies, consultants, academics, the investment community and the corporate sector. To remain consistent with market expectations and developments in ESG practice, the inclusion criteria are revised regularly. FTSE Russell engages with companies that no longer meet the standards and they are given a period of grace to try and improve their scores. If there is no improvement, then the company is deleted from the index series. The criteria have been designed to help investors minimize ESG risks. Companies with the largest risk and impacts have to meet additional sector specific criteria.
