



Business Description

Akiles Corp SE is primarily involved in the two business areas namely Infrastructure and Utilities sector and Tourism sector. The Company operates mainly in the Balkans, Spain, and Greece.

Valuation as of 2 May 2024

Akiles Corp achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 0.13, above the previous closing price of 0.11. The stock has been trading between a 33.94% discount and 9.16% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 76th percentile in the coverage universe and 64th percentile in the industrials sector (higher percentile indicates more undervalued).

The quantitative uncertainty rating for Akiles Corp is Extreme.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 01/01/2024, when it was Very High.

The main drivers of the company's valuation and uncertainty are its EV-MV ratio and drawdown. The enterprise value-to-market value ratio of 1.63 falls at the 81st percentile in the equity universe and the 80th percentile in its sector. The trailing 12-month maximum drawdown of 0.00% corresponds to the 5th percentile overall and the 5th percentile in the industry.

Economic Moat ^Q as of 10 Feb 2021

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.93 sits at the 86th percentile in the industrials sector. This is a decrease from 0.96, the maximum of its moat scores over the past year.

The quantitative financial health rating for Akiles Corp is Moderate. Its financial health score, termed Distance to Default, sits at the 71st percentile in both the universe and sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Akiles Corp is -259.45%, and its enterprise value-to-market value ratio is 1.63. They sit at the 5th and above the 81st percentile in the global equity universe, respectively.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
