



#### **Business Description**

Grenergy Renovables SA is a Spanish Independent Power Producer (IPP) that designs, develops, and executes renewable energy plants on a large scale. Its services are divided into different activities including the promotion, commercialization, and construction of renewable energy installations, the production and commercialization of electric energy as well as any complementary activities, and the management and operation of renewable energy installations. It operates in segments that include: Development and Construction which also generates key revenue for the company; Energy; Commercialization, and Services. Geographically, the company generates revenue from Chile, Mexico, Peru, Argentina, Colombia, Spain and other regions.

## Valuation <sup>Q</sup>as of 4 May 2024

Morningstar affirms a 3-star quantitative rating for Grenergy Renovables. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 28.80, a discount of 11.76% to its Quantitative Fair Value estimate of 32.64. This discount has ranged between 40.41% and 1.74% over the past year. The stock's price to fair value ratio is at the 74th percentile in our global equity coverage universe for this methodology and at the 61st percentile relative to its peers in the industrials sector.

Grenergy Renovables furthermore holds a High quantitative uncertainty rating.

The company's quantitative star rating dates to after 03/20/2024, before which it was 4-star. Similarly, the firm's uncertainty rating changed from Very High to High after 05/02/2024.

We examine the financials and market statistics for Grenergy Renovables to determine these ratings.

Its earnings yield is 5.97% and falls at the 71st percentile in the equity universe and at the 66th percentile in the industrials sector.

## Economic Moat <sup>Q</sup>as of 6 May 2024

Quantitatively, we believe Grenergy Renovables has a Narrow economic moat. Its moat score of 0.84 corresponds to the 81st percentile in the industrials sector. Furthermore, this rating last differed from its previous rating of None on 04/25/2024, when the company's moat score fell from its maximum of 0.99 (score of 1 indicates greatest economic moat).

The company also maintains a quantitative financial health rating of Moderate. Its score sits at the 24th percentile overall and the 22nd percentile in the sector.

Examining the company's financials and market statistics, we find these ratings are principally driven by its enterprise value and annualized trailing 12-month volatility. The enterprise value is 1.57 billion, sitting at the 66th percentile in the industrials sector. The company's annualized trailing 12-month volatility is 31.57%, corresponding to the 49th percentile in the equity coverage universe and the 56th percentile in the sector.


Grenergy Renovables reports earnings per share of 1.72. Its return on invested capital is 9.34%. These values are calculated over a trailing 12-month period.

As of last market close, Grenergy Renovables has a price-to-earnings ratio of 16.74, falling at the 46th percentile in its sector (where a lower percentile means a lower ratio) and ranging between 13.31 and 201.41 over the past year.

## **Quantitative Equity Report Overview**

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. - i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
