



Business Description

Lleidanetworks Serveis Telematics SA offers services as a telecommunications operator. The company provides registered eCommunications, SMS (short message service) solutions, electronic notification, contracting, and data validation services. It serves various industries including banking, call centers, financial services, utilities, real estate, insurance agents and brokers, legal services, temporary employment agencies, and government. Its segment comprises SMS Commercial, SMS Wholesale, and SAAS. The majority of sales by business line is through ICX Wholesale Solutions. Geographically, the majority of revenue is generated nationally

Valuation as of 19 Mar 2024

Morningstar affirms a 3-star quantitative rating for Lleidanetworks Serveis. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 0.98, a discount of 46.81% to its Quantitative Fair Value estimate of 1.84. This discount has ranged between 63.14% and 37.29% over the past year. The stock's price to fair value ratio is at the 18th percentile in our global equity coverage universe for this methodology and at the 22nd percentile relative to its peers in the communication services sector.

Lleidanetworks Serveis furthermore holds a Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 05/16/2023.

We examine the financials and market statistics for Lleidanetworks Serveis to determine these ratings. Its enterprise value-to-market value ratio is 1.45 and its annualized trailing 12-month volatility is 81.78%. These fall at the 76th and 87th percentiles in the equity universe and at the 69th and 89th in the communication services sector, respectively.

Economic Moat ^Qas of 19 Mar 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.38 sits at the 43rd percentile in the communication services sector. This is a decrease from 0.76, the maximum of its moat scores over the past year.

The quantitative financial health rating for Lleidanetworks Serveis is Moderate. Its financial health score, termed Distance to Default, sits at the 7th percentile in the universe and 10th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield for Lleidanetworks Serveis is 32.14%, and its enterprise value-to-market value ratio is 1.45. They sit at the 30th and 76th percentile in the global equity universe, respectively.

Fundamentals as of 19 Mar 2024

Lleidanetworks Serveis maintains losses per share of -0.07. The company further earns a return on invested capital of -7.06%. These values are calculated over a trailing 12-month period.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future.
