



Business Description

Lleidanetworks Serveis Telematics SA offers services as a telecommunications operator. The company provides registered eCommunications, SMS (short message service) solutions, electronic notification, contracting, and data validation services. It serves various industries including banking, call centers, financial services, utilities, real estate, insurance agents and brokers, legal services, temporary employment agencies, and government. Its segment comprises SMS Commercial, SMS Wholesale, and SAAS. The majority of sales by business line is through ICX Wholesale Solutions. Geographically, the majority of revenue is generated nationally

Valuation ^Qas of 1 May 2024

Morningstar maintains a 3-star quantitative star rating for Lleidanetworks Serveis, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 1.02, below our quantitative fair value estimate of 1.67. These shares have traded between a 63.14% and 35.97% discount to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 27th percentile; in the communication services sector, the firm's score lies at the 31st percentile (higher percentile indicates more undervalued).

Furthermore, Lleidanetworks Serveis maintains a quantitative valuation uncertainty rating of Extreme

The company has held this star rating over the past year. The uncertainty rating for Lleidanetworks Serveis has remained Extreme since the previous rating of Very High, which was last assigned on 05/16/2023.

The key factors behind these ratings are the com-

pany's EV-MV ratio and volatility. The enterprise value-to-market value ratio is 1.43, and its maximum annualized trailing 12-month volatility is 84.45%. The EV-MV ratio falls at the 71st percentile in the communication services sector while the volatility is at the 89th percentile. Over the past year, the company's EV-MV ratio has been between 1.13 and 1.65; its volatility has ranged between 44.10% and 84.45%.

Economic Moat ^Qas of 1 May 2024

Morningstar maintains a quantitative moat rating of None on the company. The firm's quantitative moat score of 0.28 sits at the 32nd percentile in the communication services sector. This is a decrease from 0.75, the maximum of its moat scores over the past year.

The quantitative financial health rating for Lleidanetworks Serveis is Moderate. Its financial health score, termed Distance to Default, sits at the 7th percentile in the universe and 8th percentile in the sector.

The significant drivers of these ratings are the company's enterprise value and enterprise value-to-market value ratio. The enterprise value for Lleidanetworks Serveis is 24.34 million, and its enterprise value-to-market value ratio is 1.43. They sit at the 22nd and 75th percentile in the global equity universe, respectively.

Fundamentals as of 1 May 2024

Lleidanetworks Serveis reports losses per share of 0.07. Its return on invested capital is -7.06%. These values are calculated over a trailing 12-month period.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

Very High – the interquartile range for possible fair values is less than 80% but greater than 35%

Extreme - the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7

- i. Last Close Price of the stock as of the close of the market of the last trading day before date of the report.
- Quantitative Valuation— Using the below terms, intended to denote the relationship between the security's Last Price and Morningstar's quantitative fair value estimate for that security.
