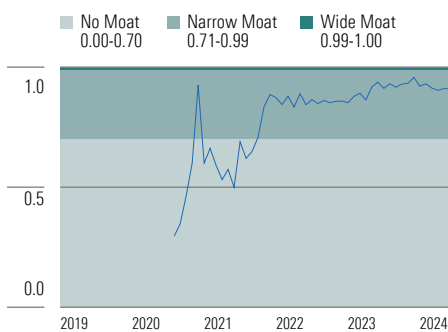

## Business Description

Robot SA designs, manufactures, and maintains systems for building control. The objective of the robot system is to optimize the control of installations in buildings and industries and facilitate the management of their consumption.

## Valuation <sup>Q</sup> as of 10 May 2024

Morningstar affirms a 3-star quantitative rating for Robot. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 1.80, a discount of 19.37% to its Quantitative Fair Value estimate of 2.23. This discount has ranged between 40.33% and 9.41% over the past year. The stock's price to fair value ratio is at the 57th percentile in our global equity coverage universe for this methodology and at the 41st percentile relative to its peers in the industrials sector.

Robot furthermore holds an Extreme quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Very High to Extreme after 05/08/2024.

We examine the financials and market statistics for Robot to determine these ratings. Its enterprise value-to-market value ratio is 1.89 and its trailing 12-month maximum drawdown is 0.00%. These fall at the 85th and 5th percentiles in the equity universe and at the 86th and 5th in the industrials sector, respectively.

## Economic Moat <sup>Q</sup> as of 10 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Robot falls at the 88th percentile in the industrials sector and at the 92nd in the equity coverage universe. The com-

pany has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Robot. The company's raw score on this metric, termed Distance to Default, ranks at the 67th percentile overall and in the industrials sector. Furthermore, this financial health rating has stayed Moderate over the last year.

Supporting these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio of 1.89, ranks at the 85th percentile in the covered equity universe and at the 86th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.89, falls at the 85th percentile in the universe and the 86th percentile in the industrials sector.

## Fundamentals as of 10 May 2024

Robot maintains losses per share of -0.08. The company further earns a return on invested capital of -0.57%. These values are calculated over a trailing 12-month period.

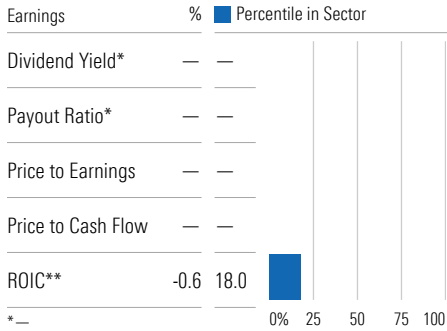

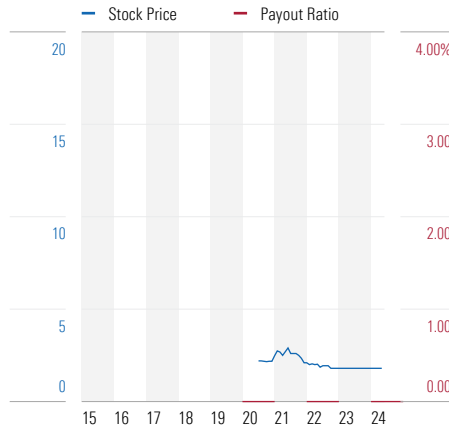

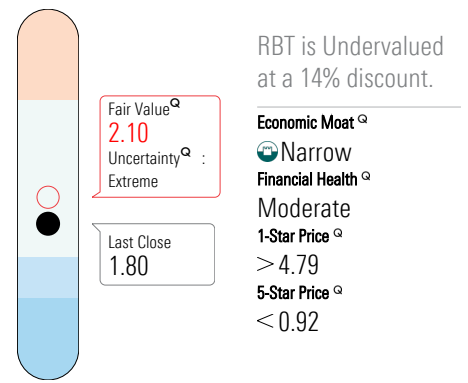

## Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ### Quantitative Equity Ratings

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

**Low** – the interquartile range for possible fair values is less than 10%

**Medium** – the interquartile range for possible fair values is less than 15% but greater than 10%

**High** – the interquartile range for possible fair values is less than 35% but greater than 15%

**Very High** – the interquartile range for possible fair values is less than 80% but greater than 35%

**Extreme** – the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

**Weak** – assigned when Quantitative Financial Health < 0.2

**Moderate** – assigned when Quantitative Financial Health is between 0.2 and 0.7

**Strong** – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. **Last Close** – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation** – Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.
