



Business Description

Alquiber Quality SA provides vehicles on rental basis. The company offers cars, trucks, vans, SUV's, and pick-ups vans.

Valuation as of 3 May 2024

Alguiber Quality achieves a 3-star quantitative star rating based on Morningstar's equity model. This reflects the company's valuation and uncertainty scores under this assessment system.

The Quantitative Fair Value estimate is 10.43, inline with the previous closing price of 10.50. The stock has been trading between a 21.12% discount and 2.75% premium to its quantitative fair value over the past year. The stock's current valuation rating sits at the 91st percentile in the coverage universe and 87th percentile in the industrials sector (higher percentile indicates more undervalued). The quantitative uncertainty rating for Alguiber Quality is Extreme.

Our quantitative star rating remains unchanged over the past year; the uncertainty rating last differed on 10/06/2023, when it was Very High.

The main drivers of the company's valuation and uncertainty are its earnings yield and drawdown. The earnings yield of 3.11% falls at the 53rd percentile in the equity universe and the 42nd percentile in its sector. The trailing 12-month maximum drawdown of 6.31% corresponds to the 5th percentile overall and the 5th percentile in the industry.

Economic Moat as of 3 May 2024

Morningstar maintains a Narrow quantitative moat rating on the company. The firm's quantitative moat score of 0.9 sits at the 84th percentile in the industrials sector. This is a decrease from 0.97, the maximum of its moat scores over the past year. The quantitative financial health rating for Alquiber

Quality is Strong. Its financial health score, termed Distance to Default, sits at the 87th percentile in the universe and 89th percentile in the sector.

The significant drivers of these ratings are the company's book value yield and annualized trailing 12month volatility. The book value yield for Alquiber Quality is 20.86%, and its annualized trailing 12month volatility is 10.28%. They sit at the 21st and 5th percentile in the global equity universe, respectively.



Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.
