



Business Description

AB Biotics is is a biotech company that focuses on the research and development of a vast generation of natural probiotic strains formulated not only to meet therapeutic needs but also to maintain human health.

Valuation ^Qas of 1 May 2024

Morningstar affirms a 3-star quantitative rating for AB Biotics. We calculate this outcome using the company's underlying model-driven valuation and uncertainty scores.

The stock's last closing price was 5.00, a premium of 5.62% to its Quantitative Fair Value estimate of 4.73. The stock has been trading between a 19.74% discount and 16.01% premium to its quantitative fair value over the past year. The stock's price to fair value ratio is at the 95th percentile in our global equity coverage universe for this methodology and at the 95th percentile relative to its peers in the healthcare sector.

AB Biotics furthermore holds a Very High quantitative uncertainty rating.

The company's quantitative star rating remains unchanged over the past year. The firm's uncertainty rating changed from Extreme to Very High after 02/21/2024.

We examine the financials and market statistics for AB Biotics to determine these ratings. Its book value yield is 12.59% and its earnings yield is 3.79%. These fall at the 14th and 57th percentiles in the equity universe and at the 24th and 82nd in the healthcare sector, respectively.

Economic Moat as of 1 May 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for AB Biotics falls at the 90th percentile in both the healthcare sector and equity coverage universe. The company has

maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to AB Biotics. The company's raw score on this metric, termed Distance to Default, ranks at the 71st percentile overall and 74th in the healthcare sector. Furthermore, this financial health rating most recently changed from Strong after 04/26/2024.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 12.59%, ranks at the 14th percentile in the covered equity universe and at the 24th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.57, falls at the 79th percentile in the universe and the 86th percentile in the healthcare sector.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.
