



### **Business Description**

Secuoya Grupo De Comunicacion Sa operates a video production facility. It is engaged in the creation, production and distribution of audiovisual and digital content. The company also offers support and business process outsourcing.

## Valuation <sup>Q</sup>as of 30 Apr 2024

Morningstar maintains a 3-star quantitative star rating for Secuoya Grupo De, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 5.55, above our quantitative fair value estimate of 5.21. These shares have traded between a 19.04% discount and 14.73% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 95th percentile; in the communication services sector, the firm's score lies at the 95th percentile (meaning the shares are more undervalued than 95% of stocks in the sector).

Furthermore, Secuoya Grupo De maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating over the past year. The uncertainty rating for Secuoya Grupo De has remained Very High since the previous rating of Extreme, which was last assigned on 02/14/ 2024.

The key factors behind these ratings are the company's book value yield and earnings yield. The book value yield is 2.99%, and its maximum earnings yield is 1.68%. The book value yield falls at the 10th percentile in the communication services sector while the earnings yield is at the 51st percentile. Over the past year, the company's book value yield has been between 2.99% and 2.99%; its earnings yield has ranged between 1.68% and 1.68%.

### Economic Moat <sup>°</sup>as of 30 Apr 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Secuoya Grupo De falls at the 84th percentile in the communication services sector and at the 87th in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Secuoya Grupo De. The company's raw score on this metric, termed Distance to Default, ranks at the 71st percentile overall and 70th in the communication services sector. Furthermore, this financial health rating most recently changed from Strong after 04/02/2024.

Supporting these ratings are the company's book value yield and enterprise value-to-market value ratio. The book value yield of 2.99%, ranks at the 8th percentile in the covered equity universe and at the 10th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.54, falls at the 79th percentile in the universe and the 75th percentile in the communication services sector.

### Fundamentals as of 30 Apr 2024

The earnings per share for Secuoya Grupo De is 0.63. The company earns a return on invested capital of 11.65%, falling at the 80th percentile in the communication services sector. The company did not report a dividend. We calculate the above figures over a trailing 12-month period.



# Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. ## **Quantitative Equity Ratings**

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analystdriven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

i. **Quantitative Fair Value Estimate:** Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

**Narrow** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

**Wide** – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

**None** – assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iii. **Quantitative Star Rating:** Intended to be the summary rating based on the combination of our Quantitative Fair Value Estimate, current market price, Quantitative Uncertainty Rating, and momentum. The rating is expressed as One-Star, Two-Star, Three-Star, Four-Star, and Five-Star.

After the initial calculation for the star rating, there is a final filtering step based on the momentum of the company. We rank the companies based on their 12-1 month momentum, then restrict those below the 30th percentile to a maximum of 3 stars.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10% Medium – the interquartile range for possible fair values is less than 15% but greater than 10%

High – the interquartile range for possible fair values is less than 35% but greater than 15%

 $Very\ High\ -$  the interquartile range for possible fair values is less than 80% but greater than 35%

 $\ensuremath{\textit{Extreme}}\xspace -$  the interquartile range for possible fair values is greater than 80%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak – assigned when Quantitative Financial Health < 0.2

Strong – assigned when Quantitative Financial Health > 0.7

### Other Definitions

i. Last Close – Price of the stock as of the close of the market of the last trading day before date of the report.

ii. **Quantitative Valuation**– Using the below terms, intended to denote the relationship between the security's **Last Price** and Morningstar's quantitative fair value estimate for that security.

**Undervalued – Last Price** is below Morningstar's quantitative fair value estimate.

Farily Valued – Last Price is in line with Morningstar's quantitative fair value estimate.

Farily Valued – Last Price is in line with Morningstar's quantitative fair value estimate.

**Overvalued – Last Price** is above Morningstar's quantitative fair value estimate.

Sustainalytics ESG Risk Rating Assessment: The ESG Risk Rating Assessment is provided by Sustainalytics; a Morningstar company. Sustainalytics' ESG Risk Ratings measure the degree to which company's economic value at risk is driven by environment, social and governance (ESG) factors.

Sustainalytics analyzes over 1,300 data points to assess a company's exposure to and management of ESG risks. In other words, ESG Risk Ratings measures a company's unmanaged ESG Risks represented as a quantitative score. Unmanaged Risk is measured on an open-ended scale starting at zero (no risk) with lower scores representing less unmanaged risk and, for 95% of cases, the unmanaged ESG Risk score is below 50.
