



Business Description

Zinkia Entertainment SA is engaged in the entertainment sector. It develops and produces television series, movies, and video games. The company's brand profile includes Pocoyo, Mola Noguru, Shuriken School, and others. Its series and apps are distributed on different platforms and devices such as TV, VOD, DVD, mobile devices, YouTube, among others.

Valuation as of 26 Apr 2024

Morningstar maintains a 3-star quantitative star rating for Zinkia Entertainment, derived from the firm's valuation and uncertainty scores.

The company's shares last closed at 0.57, in-line with our quantitative fair value estimate of 0.58. These shares have traded between a 22.9% discount and 1.94% premium to their fair value estimate over the past year. In Morningstar's equity coverage universe for this methodology, the company's valuation rating lands at the 89th percentile; in the communication services sector, the firm's score lies at the 93rd percentile (meaning the shares are more undervalued than 93% of stocks in the sector).

Furthermore, Zinkia Entertainment maintains a quantitative valuation uncertainty rating of Very High.

The company has held this star rating over the past year. The uncertainty rating for Zinkia Entertainment has remained Very High since the previous rating of Extreme, which was last assigned on 03/13/2024.

The key factor behind these ratings is the company's earnings yield of 0.87% which falls above the 47th percentile in the communication services sector. Over the past year, the company's earnings yield has been between 0.87% and 0.87%.

Economic Moat ^Qas of 26 Apr 2024

With a Narrow Morningstar quantitative moat rating, the quantitative moat score for Zinkia Entertainment falls at the 89th percentile in the communication services sector and at the 91st in the equity coverage universe. The company has maintained its Narrow quantitative moat rating for the last year.

We also assign a Moderate quantitative financial health rating to Zinkia Entertainment. The company's raw score on this metric, termed Distance to Default, ranks at the 73rd percentile overall and 72nd in the communication services sector. Furthermore, this financial health rating most recently changed from Strong after 04/02/2024.

Supporting these ratings are the company's enterprise value-to-market value ratio and enterprise value-to-market value ratio. The enterprise value-to-market value ratio of 1.55, ranks at the 79th percentile in the covered equity universe and at the 76th percentile among its peers. Meanwhile, its enterprise value-to-market value ratio of 1.55, falls at the 79th percentile in the universe and the 76th percentile in the communication services sector.





Quantitative Equity Report Overview

The quantitative report on equities consists of data, statistics and quantitative equity ratings on equity securities. Morningstar, Inc.'s quantitative equity ratings are forward looking and are generated by a statistical model that is based on Morningstar Inc.'s analyst-driven equity ratings and quantitative statistics. Quantitative Equity Ratings

Morningstar's quantitative equity ratings consist of: (i) Quantitative Fair Value Estimate, (ii) Quantitative Star Rating, (iii) Quantitative Uncertainty, (iv) Quantitative Economic Moat, and (v) Quantitative Financial Health (collectively the "Quantitative Ratings).

The Quantitative Ratings are calculated daily and derived from the analyst-driven ratings of a company's peers as determined by statistical algorithms. Morningstar, Inc. ("Morningstar", "we", "our") calculates Quantitative Ratings for companies whether or not it already provides analyst ratings and qualitative coverage. In some cases, the Quantitative Ratings may differ from the analyst ratings because a company's analyst-driven ratings can significantly differ from other companies in its peer group.

- i. Quantitative Fair Value Estimate: Intended to represent Morningstar's estimate of the per share dollar amount that a company's equity is worth today. Morningstar calculates the Quantitative Fair Value Estimate using a statistical model derived from the Fair Value Estimate Morningstar's equity analysts assign to companies. - ii. **Quantitative Economic Moat:** Intended to describe the strength of a firm's competitive position. It is calculated using an algorithm designed to predict the Economic Moat rating a Morningstar analyst would assign to the stock. The rating is expressed as Narrow, Wide, or None.

Narrow – assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 70% but less than 99%.

Wide — assigned when the probability of a stock receiving a "Wide Moat" rating by an analyst is greater than 99%.

None — assigned when the probability of an analyst receiving a "Wide Moat" rating by an analyst is less than 70%.

iv. **Quantitative Uncertainty:** Intended to represent Morningstar's level of uncertainty about the accuracy of the Quantitative Fair Value Estimate. Generally, the lower the Quantitative Uncertainty, the narrower the potential range of outcomes for that particular company. The rating is expressed as Low, Medium, High, Very High, and Extreme.

Low – the interquartile range for possible fair values is less than 10%
Medium – the interquartile range for possible fair values is less than 15%
but greater than 10%

v. **Quantitative Financial Health:** Intended to reflect the probability that a firm will face financial distress in the near future. The calculation uses a predictive model designed to anticipate when a company may default on its financial obligations. The rating is expressed as Weak, Moderate, and Strong.

Weak — assigned when Quantitative Financial Health < 0.2

Moderate — assigned when Quantitative Financial Health is between 0.2

and 0.7

Strong – assigned when Quantitative Financial Health > 0.7
